

# Memorandum Of Understanding

**Gujarat Police Academy, at Karai, Gandhinagar, Gujarat, is an autonomous body of Gujarat State, herein after referred as GPA and the Raksha Shakti University, Ahmedabad herein after referred as RSU, wishes to cooperate closely in development of a collaborative working relationship in field of Study, Training, Research and sharing of knowledge for mutual benefit. This MoU is based on fairness and equality and evidently, each step in the co-operative relationship would be based on mutual consent and consultation.**

### I. PURPOSE :

- 1). The general purpose of this MoU is to establish an enduring framework for educational relation and co-operation between the two participating institutions in order to promote academic learning, training, research and explore the possibility of joint academic programmes.

- 2). To encourage the **RSU** to initiate and undertake the task of **“Training Of Trainers” (TOT)** to Train the Police personnel of GPA.
- 3). To encourage/promote/initiate relationship between the GPA and **RSU** for basic Training, execution of knowledge in Police Investigation .

## **II. Objectives :**

- 1). To participate in organizing seminars, training courses, workshops and programmes jointly and independently in the field of common interest.
- 2). To exchange scholars and expert faculties for sharing experience and knowledge.
- 3). To facilitate visits by trainers and trainees from each institutes to the other.
- 4). To exchange and access of academic publication materials, library, computer labs, information, data, other research works related to common interest.
- 5). To share infrastructures and other facilities requires for academic and research purposes.
- 6). Any other areas which come across in future and agreed mutually for common interest.

## **III. Terms & Agreement :**

- 1). GPA or **RSU** shall identify the areas of training and study.
- 2). Both institutes exchange their scholars, experts faculties and trainers as per the programme arranged by either institute.

- 3) In the event of joint organized programme, both institutes shall have to decide mutually about the availabilities of conveyance, lodging- boarding and other expenses etc. well in advance.
- 4). The institute who invites the scholars / experts faculties for it's academic purpose shall have to recognize the service with due honorarium with adequate facilities for transportation.
- 5) Both institutes shall demonstrate synergy of efforts as a team for smooth conduct of courses/programmes etc., and ensure direct interface with one another without involving external agency or specialists.
- 6) Both institutes shall take all reasonable steps to ensure the successful completion of the collaboration and co-operate each other in duly carrying out the obligations agreed upon.
- 7) Both institutes shall appoint a nodal officer for communication with each other.
- 8). Both institutes shall maintain confidentiality about any information course material, plan, discussion, strategy or any material, disclosed under the MoU shall be deemed to be confidential and shall be marked accordingly. Any information, course material or like in the public domain shall not be part of this commitment.
- 9) Any confidential information received by either institution, under, by virtue of this agreement shall be maintained in the strict confidence and trust, and shall be used for the agreed purpose under this MoU only.
- 10) It is an obligation of all the participants to observe rules and regulations of the respective institutes. Further, GPA is a training institute for police personnel and other sensitive

trainings and operations. It is covered under the Official Secret Act, 1923 and therefore entire campus is a prohibited place for photography & videography. It is also declared as Free plastic Zone & No tobacco zone and the participants are required to strictly follow the instructions in this regard.

- 11) This MoU will remain in force for unlimited duration until terminated by six months prior written notice given to one institute by the another institute.
